 - The person is a family member or friend and is visiting for the purpose of promoting model car racing to a new participant or spending time with friends or family,



When arriving and using CLUB KEY to obtain the key from the security box to unlock Gate A&B.

- 1. Ensure that Gate A is locked immediately after entering Helles Park.????
- 2. Ensure that the security key is returned to the security box immediately after unlocking Gate A&B and that the security box is locked.
 - NOTE; Gate B is not required to be relocked whilst you are on site
 - NOTE; Gate C is opened using the Club key.
 - NOTE; Gate C is not required to be relocked whilst you are on site at
 - Club Meetings or Official Practise Days.
- 3. When leaving the Helles Park site for any purpose.
- 4. Ensure that Gates C and B are locked.
- 5. Ensure that the key is returned to the security box after unlocking Gate A
- 6. Ensure that Gate A is locked when leaving the Helles Park site.
